Tribal-State Decree Adopted

On August 24, the Federal Court in Kalamazoo issued an order implementing an agreement presented by the United States, the State of Michigan, and four Michigan Indian tribes that directly impacts the health and availability of the fishery in the northern Great Lakes. The agreement replaces one implemented in 2000 governing commercial fishing by five Michigan Tribes in northern waters of Lakes Michigan, Huron and Superior. That 2000 agreement had reduced commercial gillnet fishing, promoted lake trout rehabilitation, and encouraged a working relationship between the Tribes and sportfishing interests.

The Coalition to Protect Michigan Resources, of which the MCBA is a principal



member along with the MUCC, the Michigan Steelheaders and over a dozen other organizations, filed objections to the proposed agreement earlier this year. At a two day hearing in Federal Court in late May, the Coalition explained the biological and scientific shortcomings in the new agreement, noting that the new agreement expands gillnet fishing by the Tribes to large areas of the Great Lakes that haven't had gillnets fished in decades, promotes the use of gillnets at a time when lake trout and whitefish are in serious decline in many areas of the Great Lakes, shrinks refuges that promoted lake trout rehabilitation, and reverses the path the parties had pursued for 35 years. These objections were opposed by the United States, the State of Michigan, and four Indian tribes. In its

MRO service First Advantage maintains the random selection pool, ensures testing throughout the year at the current USCG rate.

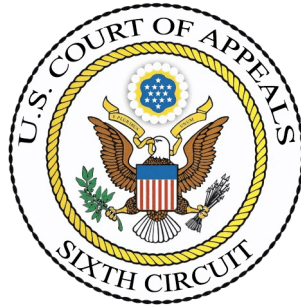

August ruling, the Court overruled the Coalition's (and MCBA's) objections. The Court contemporaneously approved and entered the '2023 Great Lakes Fishing Decree'.

Despite overruling the Coalition's objections, the Court provided the Coalition with the right to appeal to the U.S. Court of Appeals in Cincinnati. The Coalition must file its appeal by late October if it chooses to do so. (In an earlier appeal involving the Coalition, the Court of Appeals recognized the importance of the Great Lakes fisheries to all in this



state and nationally while suggesting that the Coalition might have the opportunity to appeal an adverse decision by the Federal Court.) Accordingly, the Coalition and its member organizations must decide whether an appeal should be filed.

From the Helm . . .



It's been a very busy summer. Since the last Cannonball was



published, Federal Judge Maloney issued his final approval of the new Tribal Consent Decree. The sport fishing industry took a beating in the negotiations for this new Consent Decree.

The Coalition to Protect Michigan Resources exhausted every option available to prevent the adoption of what we believe is a bad Consent Decree. We raised real biological issues with the Court but the Judge ignored them. Federal Judge Maloney gave final approval to a new 24 year agreement, which we believe is full of loopholes and which includes increased tribal gillnet fishing that we also believe will negatively impact our fishery. It will go into effect soon, with the main parties ironing out the implementation details at this time.

The Coalition is currently weighing what our options are concerning the Decree and the Court's order. The Judge did provide an option to appeal the Consent Decree. The coalition will consider it fully. Meanwhile, don't count on the states negotiating team or the DNR to protect your fishery during the term of this new Consent Decree.

I've spent over six years dedicated to this issue. The Association and the coalition have devoted endless hours to this issue. But unfortunately our efforts were not successful. Sadly, I've talked to some Captains who have pretty much stated that until nets are dropped in their fishing area, it really doesn't matter to them. "Fishing is good" they say! That may be true at the moment, but history

has a way of repeating itself. Gillnets and overfishing decimated the fishery in the 19th and 20th centuries, and the new Consent Decree may make it possible for it to happen again.

In other major Association news, this will be our first all-digital Cannonball newsletter. The board approved the decision to move to digital to reduce the cost and create a newer, better, Cannonball, which will reach all our members faster.

Also in the major news category, the board has authorized a new streamlined fall conference format, designed to serve the membership better, increase attendance, lower cost, and lead to the opportunity for more members to be present for the fall business meeting. The newly re-organized MCBA Fall Conference will be on October 28 at the Haworth Hotel at Hope College in Holland, Michigan. The conference has been shrunk down to a 1-1/2 day event, with all the main events occurring on the one day; Saturday, October 28. The Friday evening activities are optional, but will be interesting to those who like to participate at a greater level. I hope this new one day format will make it easier for you to attend. I'm hoping for a great fall conference using this new format. Your opinion on fishing issues and your voice needs be heard by our DNR leadership who will be present. I hope to see you there also.

Changing the conversation and looking to the fishing season now in the fall of 2023. It's been a good summer. Charter trips are about average from the Captains I've talked with.

Salmon fishing from Manistee south has been fantastic. Frankfort north has

not been as good. Northwest Michigan is hurting for bait and silver fish. Lake Trout fishing was fantastic late May and all of June. Starting in July it started to fizzle and by August fishing was tough in the northern waters.

As always, the Walleye fishing was excellent in Saginaw Bay, Lake St. Clair and Lake Erie. However, Saginaw Bay fishers better start being extra vigilant. It appears that the commercial fishing industry is coming after the Walleye. We will all need to be alert and vigilant to confront this potential threat to the Saginaw Bay fishery.

Reviewing from the top: The Consent Decree has been settled in a way that concerns us greatly. The Association is adopting an new all-digital Cannonball. We are embarking on a new fall meeting format. It's been a busy four years for me since I was elected President in 2019. Four years of many challenges to our Association and our fishery. Here's hoping the work we've done will pay off in the future. I will be at the preconference meetings the evening of October 27, and at the full day fall conference on October 28. Hope to see you there! 🐟

The proposed consent decree is now law. You have all heard the board's many concerns for years now regarding what the decree allows. During this process, you have witnessed the MCBA and other entities representing the interest of the general public, being denied access to the negotiation process. While I have several issues over what is allowed in the new decree, let me share with you one of my biggest concerns.

As written, the consent decree does not mandate a requirement for sharing information with the public, such as catch reports or violations of treaty vessels. It also does not provide a mechanism for independent third party observation of treaty vessel fishing operations. Rather, it has been left up to the consent decree participants to 'self' regulate.

I hope you are as shocked as I am with this aspect of the consent decree. It is not that hard to draw the conclusion that what happens out of sight of the public view, can easily lead to abuse of the rules set forth in the decree. As the old saying goes "Figures don't lie, but lairs sure can figure" comes to mind.

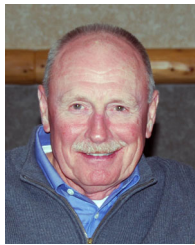
I would encourage MCBA members to be vigilant when near these vessels while on the water. If you see something that doesn't look right, it probably isn't, and you need to speak up immediately to us here at the MCBA and report your concern to the DNR as well.

Central Lake Michigan

It has been a good summer for fishing in Central Lake Michigan. Anglers reported consistent catches of King and Coho Salmon. We have not seen as many big Kings this year. Last summer Captain Chucks II in Ludington reported sixty-six 30 plus pound

King Salmon weighed in at their shop in Ludington. This year the average fish weighed in was between 25 and 27 lbs. Only thirteen 30 plus pound Kings were weighed in this year. Our personal best was a little over 26 lbs. Last year it was 33.34 lbs. We were seeing more Coho this summer. It looks like the Coho plants at Ludington State are paying off. Did not hear any complaints from clients about fish size. All the fish appeared healthy and well fed.

Some trap nets were set in central Lake Michigan waters by a tribal fisherman. They were well marked, and locations published on the web and at local tackle shops. We appreciated the cooperation from the tribal fisherman.

Hope to see you at MCBA's Annual Fall Conference on October 28th in Holland. I am looking forward to being there!

I fish Lake Erie from April to mid June so I did not personally get to enjoy the early season Lake Trout or salmon fishing and based on reports the pattern seemed similar with the season starting off with good catches this spring for lake trout. King Salmon of all age classes then showed up in decent numbers, but then were scarce, at least for me the last half of July, luckily Lake

Trout and steelhead fishing options were available. Salmon fishing was good in August but wind has seemingly been more of a factor this August blowing hard either from the north or the south with several charters either re-booked to a different date or canceled.

Harbor and Bete Grise. Good mixed bag catches of Lake Trout, some Coho and unexpected influx of Pink Salmon. For a while they would disappear and then return again. Reports from my friends in Marquette mirrored our situation. My neighbor Dylan (who I occasionally will "fun fish" on his boat on my day off), told me that on his recent trip he had a Coho about 10 pounds smack a spoon 60 feet down on a rigger, surfaced in a heartbeat and then stripped off 150 feet of line... tail walking like a Marlin!!! NO he didn't get it on video before it threw the hook.

The Pinks and Cohos really turned on in mid July and by mid August the really bulked up. This is the reason why. Alewife and Smelt population is stable and supplemented with an explosion of Sisco. See...

And even, in some cases, more timely and better articles. Change is hard, but it needed to be done. If you are like me, you will print your digital newsletter and add it to your permanent file of paper newsletters, and keep the file going. I know how interesting it is to look back through my old printed files from time to time.

And there's more: Almost from the beginning, the Association has struggled to find a meeting time and format which would best serve the members and the Association. We tried spring; we tried fall; we tried different dates, and lots of different and interesting locations. Even free breakfasts and lunches. We planned really interesting and informative sessions, yet the attendance never matched the hoped for and necessary goals. Meanwhile it was becoming more and more difficult to find venues at reasonable costs, and the cost for meals and other expenses kept rising. So, after much discussion and debate the board has changed the structure to a new format; much shorter, much less expensive, while still trying to maintain the essential parts from the previous format, including the informative speaker sessions.

The apparent final settlement of the Consent Decree dismayed the officers and the board. Especially Pres. Bill Winowiecki, and coalition President, Tony Radjenovich. As leaders in the coalition, they have spent uncounted hours trying to make the Consent Decree something we could be proud of. Now we know, without success. The coalition went to court to require the state to allow us to participate directly. Judge Paul L. Maloney rejected the coalition's motion to intervene. As a result, the coalition was unable to bring either the

biology we know and understand or the institutional history directly into the negotiations. Having been kept from participating, it is almost certain that the now approved consent decree will be bad for the sport fishery of the Great Lakes, and will set a precedent for even worse future decisions. We fought to make clear to all that the consent decree should represent good biology, good stewardship of the resources, and to be consistent with the institutional history of past decisions which were made to eliminate indiscriminate killing of sport fish by gill net fishing. We fought for decades to eliminate gill nets, that indiscriminately kill fish of all species. It appears that the new decree moves away from the past and toward more of this indiscriminate method of fishing. We may be witnessing the beginning of the end of charter fishing in much of the great lakes.

Turning my thoughts to fishing for some relief from the terrible Consent Decree news, I note that central Lake Michigan, the region I used to represent, had a fairly strong season this year. There was enough bait this spring to cause a small but noticeable die-off, and the bait remained strong in the area all summer. It was a good summer for Kings, and for Coho's as well. As the season progressed the fishing was mostly strong, with good numbers of good sized fish. If good fishing was our only concern it would have been a good

summer, at least in my region.

But I return to the big issues that our hardworking board and officers continue to deal with. Threats to the fishery and the charter industry. The consent Decree

turned out badly. How it is implemented will need to be watched closely. Commercial fishing issues, especially for Walleye in Saginaw Bay keep reappearing. They have not gone away. For these and other issues, much vigilance will be required.

Are you considering retiring or taking a break, but want to keep in touch with you MCBA friends and colleagues? Become a retired member. I am; It's easy and not expensive. Look at the membership page of

the website for details. If you're reading this, most likely you are already a member of the MCBA. Changing from an active member to a retired member is easy when you're ready to do it.
